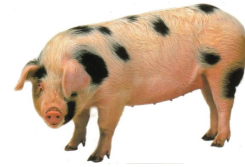

Pre-registration is required for pen space. Registration and payment must be received by June 19, of the current year, at the Ionia Free Fair Office. There is no entry fee for 2017. Exhibitor parking passes ordered on the entry form will receive the discounted price. Please use the swine entry form located at the end of this department.

Market hogs will be weighed as they come off a trailer or truck. If dirty or foul smelling they will be washed before weighing. All livestock trailers must be parked in designated areas only.

All swine exhibitors are expected to assist with all aspects beginning with weigh in through cleanup of equipment after release of animals.

Only Ionia County residents may exhibit market swine.

All animals entered, except where otherwise specified, must be eligible to registry for all swine over six months of age, and also certificate of transfer if not bred by exhibitor, if requested to do so by the Superintendent.

The importation of swine vaccinated for pseudorabies is prohibited except upon a special permit issued by the director. No swine shall be presented for exhibition purposes which have originated from any garbage feeding premise or that are in a quarantine area for the prevention of the spread of vesicular exanthema, or if a quarantine is one of the premises for any reason (except upon a permit from the Department of Agriculture or his authorized agent).

All feeder swine imported into Michigan shall meet one of the following requirements:

- a. Originate directly from a qualified negative pseudorabies free herd or directly from a feeder pig monitored herd, OR
- b. Originate directly from a state which participates in a pseudorabies testing program that is approved by the director, OR
- c. Originate directly from a pseudorabies free state or region as designated by the United States department of Agriculture or as determined by the director.
- d. Swine shall be indentified by official identification (official identification means an identification ear tag or tattoo or other identification approved by USDA or MDA).

Ionia Free Fair is not responsible for lost, stolen, or damaged articles prior to, during, or after the Fair.

Exhibitors are required to purchase a **one day** parking pass at the reduced rate of only \$4.00 at the time of entering their exhibit or project. This pass will be good for one day of the Fair scheduled for July 13-22. Exhibitors may purchase an Exhibitor **Season** Parking Pass for only \$16.00, good for all 10 days of the Fair. Parking fee proceeds are directed to facility maintenance and enhancements.

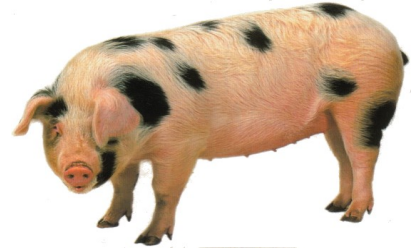

1. The mandatory tag in for all swine will be at the Fairgrounds from 8:00 am to 11:30 am on the third Saturday in April. Must provide superintendent with sellers name, address and phone number at weigh in. This information must be provided to the state.
2. An exhibitor can weigh in 5 hogs.
3. Swine weigh in will be held the first Friday of the Fair from 5:30 pm to 8:00 pm, no weighing after 8:00 pm. Meat sale order is by rows.
4. To be eligible for the market show and sale hogs, they must weigh between 220 and 300 lbs., but will only get paid up to 285 lbs.
5. An exhibitor may show 2 animals in meat animal show 1 gilt and 1 borrow.
6. Up to 10 or more classes of gilts and borrows.
